## **Case Report**

#### Introduction

This paper provides the Committee with an update on the cases that have been heard by panels of the Committee since its last meeting. The report provides an update on cases that were heard between 15<sup>th</sup> January 2007 and 10<sup>th</sup> April 2007

Between 1<sup>st</sup> April 2006 and 15<sup>th</sup> January 2007, there have been 30 cases where a final disposal decision has been made. One case was a health case and one was an incorrect entry. In eight cases the panel determined that the allegation had not been proven. More information on not well founded allegations is provided in the annual report.

The notices of decision and orders for the well founded conduct and competence cases are attached, however the table below provides the Committee with the outcome and the complainant type.
