Issues of Relevance to HPC.

Relevant to HPC's own Education & Training and PPI strategies.

Two papers were presented, followed by small group discussions.

The first paper (mine) set out the international context for innovations in user involvement in health care education programmes. The second paper presented findings from a pilot study by the GCSC about involving users in the approval of a social work degree. This presentation was a useful description of a UK initiative probably the first example of a project to involve users in regulatory accreditation. Their full report will soon be sent to the people present at the seminar, soon. The GCSC (Graham Ixer) are currently planning a second project to involve users in their course approvals monitoring. However, an important difference exists between the GSCC and other regulators in that their structure and funding mechanisms are different. This meant that they had government money to carry out the project. Other regulators would be using registrant fees to pay for user involvement in accreditation.

The small group discussions that followed enabled people to share some questions and concerns about PPI in regulation. In my group, some time was spent on the need to clarify who could be called a user (representativeness is an old chestnut in PPI), and the potential outcomes of collaboration between regulators, users and HEI's. Themes that emerged from other groups at the feedback stage were: the high cost of involving users in accreditation;

the need for evidence about the impact and outcomes of PPI in accreditation; and the need for further discussion about methods of involvement.

The seminar ended on a positive note with people agreeing that working together means learning together: a good motto for regulators, users and HEI's.

Issues of Relevance to HPC

The poster presented 'Retention of Therapy Radiographers : what are the factors and the key issues' was extremely relevant to parts of the conference where the critical shortage of radiographers and its impact on cancer services and the barriers to increasing this was discussed as part of the subject matter in a planning paper to government ministers. The planning paper proposes strategies including changes to basic training routes, competencies etc.

In addition the conference provided me with updated professional/technical information which I will use in an update to a textbook that I am currently updating for radiotherapy students and other learners in the field (previous edition used also by nursing and medical staff). The practice of radiotherapy is undergoing a period of rapid and fundamental change due to a range of technological advances which will change the knowledge and skills needed by therapy radiographers, and influence the training they receive. They will soon be taking many more critical treatment decisions on a frequent daily basis as the medical consultants (Oncologists) will not be well placed to take these decisions.

I am grateful to the HPC for the chance to attend this conference.

Issues of Relevance to HPC

This committee considers evidence based practice and recommends change within the UK Ambulance Services.

- Problems identified with Emergency Care Practitioners working across NHS boundaries in the multi disciplinary role, having to gain CRB checks for each placement.
- Concern was expressed that Paramedics are drifting into areas of practice for which they were not primarily trained for. ("Treat and Leave" strategies)
- An update on Health professions Council matters was given by Mr McFadden, including a summary of the White Paper – The Regulation of Health Professionals in the 21st Century.
- The committee raised enquiries into the apparent high rate of Paramedics within the Fitness to Practice remit and were given an update of the Conduct and Competence Committee's findings and actions in relation to trends etc.

Key Decisions Taken

- That Mr McFadden keeps the committee updated on the implications of the white paper and Fitness to Practice issues.
- That the chairman of the committee would liaise with the British Paramedic Association with regards to appropriate training to enable Paramedics to engage with the emerging "treat and leave" strategies.

That the committee would make representations to the ambulance higher education group, to ensure that there is a consistency of further training for Paramedics when considering the emergence of new strategies caring for patients in different ways, as identified in the DoH recommendations within the "Taking Healthcare to the Patient" paper.

Issues of Relevance to HPC.

Futher action required by PPI Group to invite the CEOs of the RBs to make comments /suggestions about how the PPI Group can work across the RBs on new projects. A letter to CEOs outlining this was agreed as best course of action.

Update on PPI work by different regulatory bodies. Many adopting similar approaches using a top down and bottom up model, making reference to the PPI handbook on good practice.

Discussed benchmarking role for the PPI group, possibly developing an audit checklist of PPI activities for use across all the RBs.

There was a sense that the group had made progress in raising the profile and importance of PPI initiatives, and that many departments were adopting practices which encouraged more stakeholder engagement, and improvements in accessibility.

There was a wide ranging discussion of the implications of the White Paper. Lack of immediate and obvious response on public involvement was worrying to some members of the Group, but the consensus as that there was still a great deal of uncertainty around the timetable for the reforms and that this was limiting the response of RBs.

Speech from Andy Burnham not well received – no endorsement by conference delegates of the positive picture of reforms over last 10 years. Came under severe criticism on pay, training budgets, targets, 'marketization' of the NHS

Conference motions

- 1. Bullying and harassment in the workplace by patients/families an increasing problem
- 2. Impact of cost cutting in NHS on paramedic profession profession has highest incidence of ill health retirement in the NHS
- 3. Concerns that there is no legislation to ensure safe levels of staffing for nursing profession staff now putting their own health and safety at risk to deliver care to patients
- 4. Against NNC fees rise and against professionals paying fees to ensure public protection think the gov ought to be paying for this.

Key messages ;

Need for unions to work together to influence government thinking and resist marketisation of NHS
