The Panel did not consider that the development of a new programme was required in order to meet the conditions in the visitors report. Reasons

Having considered the observations of the education provider, the Panel is satisfied that the conditions in the Visitors' report must be met before the programme can be approved.

The Panel noted the observation from the education provider that the programme is not already approved by the HPC due to a clerical oversight. However HPC does not provide approval to programmes retrospectively. Without sufficient evidence that the programme has been approved by the Hearing Aid Council or the HPC, the HPC is not able to provide ongoing approval to the programme. The Panel noted that there had been sufficient opportunities for the education provider to provide this evidence.

The Panel noted the observation from the education provider, that the programme was identical to the MSc Audiological Science with Certificate in Clinical Competency (CCC) programme with the exception of a research module. The Panel agreed that it was a reasonable exception to allow for students enrolled on the MSc to be eligible for the register through the Post Graduate Diploma, as long as the Diploma had completed the approval process before the date of their graduation.

The Panel recorded its concern that students who had completed this programme may not be aware that the award did not in itself make them eligible to join the HPC register.

The Panel noted the observation of the education provider that a split conditions deadline was required in particular to meet SET 2.1 in full. The Panel did not consider that the development of a new programme was required in order to meet the conditions in the visitors' report. The Panel noted that the education provider may wish to develop a new combined programme in future, but this could be dealt with through a major change or separate approval process.
