Major projects summary - financial year 2008/9

Executive summary and recommendations

Introduction

This paper is to summarise to the committee the major projects that were undertaken during the financial year 2008/9.

Decision

The Council/Committee is requested to note the document. No decision is required.

Background information

During 2008/9 the organisation saw the complexity of the projects within its portfolio greatly increase. The organisation is moving away from undertaking a high number of projects to implement systems enhancements to existing systems, to concentrating on a smaller number of projects that involve substantial business process engineering, original systems design and co-ordination of multiple departments to achieve the objectives.

The main focus of last year was on designing and commencing build of the online renewals system. In addition to this, the following projects were also completed, providing the following benefits to the organisation:

Furthermore, the project to open the register to practitioner psychologists was greatly advanced, so that we are now in a good position from a process, legislative and technical perspective to open the register on 1st July 09.

Finally, although not yet completed, both the project to open the register for Hearing Aid Dispensers and the project to implement the processes required for HPC to comply with the Independent Safeguarding Authority were progressed, although they were both subject to delays in legislation.

Once again the project teams have been made up of members of nearly every department within the organisation and it is only through the effort of these teams, that the projects completed have been a success.
