Item 1.08/13 Apologies for absence

- 1.1 The Chairman welcomed Dr Khan (medical practitioner member) to his first meeting of the Committee and attendees introduced themselves.
- 1.2 Apologies for absence were received from Mrs P Blackburn.

Item 3.08/15 Minutes of the Committee 5 February 2008

3.1 It was agreed that the minutes of the twentieth Health Committee should be confirmed as a true record and signed by the Chairman.

Item 4.08/16 Matters arising

- 4.1 The Committee noted the action points arising from the last meeting.
- 4.2 The Committee noted that, at the last meeting, it had discussed the use of key performance indicators. The Chairman had raised the issue at the Council meeting on 29 March 2008 and it would be an issue which the Council could decide whether to take forward.

Item 5.08/17 Chairman's report

5.1 The Chairman reported that he had been involved in the recruitment process for the medical practitioner member of the Committee and noted the ongoing role of the practitioner member in the Committee's work.

Item 6.08/18 External review of complaints literature

- 6.1 The Committee received a paper for discussion from the Executive.
- 6.2 The Committee noted that the Fitness to Practise Forum held earlier that day had discussed a scoping report on existing research on complaints mechanisms. The Forum had recommended publication of the report as an HPC monograph and had also recommended that the Director of Fitness to Practise should bring a proposal for further research to a future meeting of the Forum.
- 6.3 The Committee agreed that it would be helpful if the proposal for further research could consider whether other organisations produced material for complainants with learning disabilities.

6.4 The Committee:

 approved the publication of the report as an HPC monograph;
agreed that the Director of Fitness to Practise should bring a proposal for further research to a future meeting of the Forum.
