High Court appeals

The appeal of Stanley Muscat was heard by the High Court on 20-22 October 2008 and the registrant's appeal was dismissed. The registrant has now applied for permission to appeal the decision to the Court of Appeal. The Conduct and Competence Committee will be provided with a report following the conclusion of the case. The case of Amna Abdalla was considered on 12 December 2008, the judge determined that the appeal was wholly without merit and awarded HPC costs of £9000. On 15 December 2008 we applied to the High Court for an extension to an interim order and this was granted. 3 other registrants have appealed decisions of the Conduct and Competence Committee, 1 case has been referred to the High

Court by CHRE and we are seeking recovery of costs in an appeal that was withdrawn
