1. Introduction

This document provides an update on the work being undertaken to complete the arrangement for Grandparenting applications. It is intended as a presentation document that will allow the Registration Committee to review project progress to date.

2. Update on Progress

- 2.1. The Registration Manager (Grandparenting) appointed to HPC November 4th.
- 2.2. Planning commenced to define transitional arrangements process. Defined in three distinct phases: Information Gathering, Planning & Production.

- 2.3. Investigation has been commenced into finding Educational Institutions, Associations and Journals for the following professions:
 - Chiropodists/Podiatrists Paramedics Physiotherapists

Of these three professions, the entities representing unregistered Chiropodists/Podiatrists received letters and forms at the end of November 2002. HPC has been receiving the replies on a daily basis since early December.

- 2.4. Lo-call number set up as an information line for Grandparenting December 9th. This is being used by the organisation to stem the tide of calls that have been received by the Grandparenting Manager and provide a front line in basic information.
- 2.5. Grandparenting page on the website has been created end December 2002 which now includes updated FAQ's, explanation & notice to Chiropodists/Podiatrists and link to press releases.

2.6. HPC has been receiving the personal details of Chiropodists/Podiatrists who are responding to the Direct mail campaign. All information is being entered into an Access database. Work commenced January 2nd and will continue until all data is captured. At this point in time we have a total of 1750 entries and an estimated 2500 remain to be Inputted. This is considerably lower than the direct mail print run. (ref: Table below)
