Executive Summary

A framework Test of Competence is being developed from the generic Standards of Proficiency. The test is being developed this way in order to give registration assessors flexibility in assessing potential registrants, because the registration assessor can adapt each part of the test to the profession they represent and relate the test to each individual's skills and experience.

Further, the framework ensures that all assessors will be applying a common approach to each assessment, thereby treating each applicant equally.
